#### Item 1.01 Entry into a Material Definitive Agreement.

On March 27, 2017, OI European Group B.V. ("OI Europe"), a private company with limited liability incorporated under the laws of the Netherlands and an indirect wholly-owned subsidiary of Owens-Illinois Group, Inc. ("OI Group"), which is the wholly owned subsidiary of Owens-Illinois, Inc. ("OI Inc."), completed a private offering of €225 million 3.125% Senior Notes due 2024 (the "Notes"). The Notes were offered and sold to the initial purchasers in reliance on the exemption from registration provided by Section 4(2) of the U.S. Securities Act of 1933, as amended (the "Securities Act"). The initial purchasers then sold the Notes to qualified institutional buyers in reliance on Rule 144A under the Securities Act and to certain non-U.S. persons in transactions outside of the United States in reliance on Regulation S under the Securities Act. The Notes are governed by an Indenture, dated as of November 3, 2016, by and among OI Europe, the guarantors party thereto, including OI Group, Deutsche Trustee Company Limited, as trustee, Deutsche Bank AG, London Branch, as principal paying agent and transfer agent, and Deutsche Bank Luxembourg S.A., as Luxembourg transfer agent and registrar.

The Notes are fully and unconditionally guaranteed, jointly and severally, on a senior basis by OI Group and by certain U.S. domestic subsidiaries of OI Group, so long as they remain guaranters of OI Group's amended and restated secured credit agreement.

The description in this Current Report of the Notes and the Indenture is not intended to be a complete description of those documents and is qualified in its entirety by the full text of the Indenture, including the form of Notes contained therein, which was filed as Exhibit 4.1 to OI Inc.'s and OI Group's combined Current Report on Form 8-K dated November 3, 2016 and is incorporated by reference in this Current Report.
