### Item 1.01 Entry Into a Material Definitive Agreement.

In connection with the sale of New Albertson's, Inc. ("NAI") by SUPERVALU INC. (the "Company") in March 2013, the Company entered into Transition Services Agreements (collectively, the "TSA") with each of NAI and Albertson's LLC to support the divested NAI banners and the continuing operations of Albertson's LLC. The TSA provides for renewal notices to be delivered no later than September 21, 2017 to extend the TSA beyond September 21, 2018. On September 21, 2017, the Company, NAI and Albertson's LLC agreed to extend this renewal notice deadline to October 17, 2017. This extension allows the parties to continue discussions and potentially agree on the specific timing and manner of the previously announced wind down and termination of the services the Company provides to NAI and Albertson's LLC under the TSA.
