MACAU, January 15, 2019 – Studio City International Holdings Limited (NYSE: MSC) today announced that Melco Resorts (Macau) Limited (the “**Gaming Operator**”) has informed the Company via its subsidiary, Studio City Entertainment Limited, that the Gaming Operator will cease VIP rolling chip operations at the Studio City Casino on January 15, 2020.
